What is the purpose of this statement?

The Russell LifePoints® Conservative Fund aims to produce returns in excess of inflation. It has a target asset mix of 80% income and 20% growth.

What are the risks of investing?




Example of how this applies to an investor

Jacob had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jacob received a return after fund fees and tax were deducted of \$462 (that's 4.62% of his initial \$10,000). Jacob also paid \$25.85 in membership fees. This gives Jacob a total return of \$436.15 for the year.
