What is the purpose of this statement?

The Russell LifePoints® Target Date 2035 Fund aims to produce returns that provide capital growth and income consistent with its current asset allocation. The allocation to income assets increases progressively until it reaches 80% in 2035.

What are the risks of investing?



Example of how this applies to an investor

Jacob had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jacob received a return after fund fees and tax were deducted of -\$63 (that's -0.63% of his initial \$10,000). Jacob also paid \$17.20 in membership fees. This gives Jacob a total return of -\$80.20 for the year.
