#### What is the purpose of this update?

This document tells you how the Lifetime Property Fund (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Trustee Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.


#### **Description of this fund**

The Lifetime Property Fund seeks to track (before annual fund charge and tax) the S&P/NZX Real Estate Select Index. The Fund provides exposure to domestic commercial property and is expected to experience high volatility.

# What are the risks of investing?

#### Risk indicator for the Lifetime Property Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



# What fees are investors charged?

Annual membership fee calculation involves calculating the total of member fees payable across all those participating employers where the member pays for the fees and dividing by the total number of members from all participating employers and multiplying by 12 to convert to an annual average. Annual membership fees were charged during the period however they are no longer charged.

Small differences in fees and charges can have a big impact on your investment over the long term.


#### Example of how this applies to an investor

Ben had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben incurred a loss after fund charges and tax were deducted of \$1,543.78 (that is -15.44% of his initial \$10,000). Ben also paid \$22.35 in other charges. This gives Ben a total loss after tax of \$1,566.13 for the year.

#### What does the fund invest in?


#### Actual investment mix
