What is the purpose of this statement?

Description of the fund

The Russell LifePoints® Conservative Fund aims to produce returns in excess of inflation by investing mostly in income assets with only a modest allocation to growth assets.

What are the risks of investing?

Risk indicator for the Russell LifePoints® Conservative Fund:


How has the fund performed?

Example of how this applies to an investor

Jacob had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Jacob received a return after fund fees and tax were deducted of \$71 (that's 0.71% of his initial \$10,000). Jacob also paid \$28.24 in membership fees. This gives Jacob a total return of \$42.76 for the year.
