What is the purpose of this update?

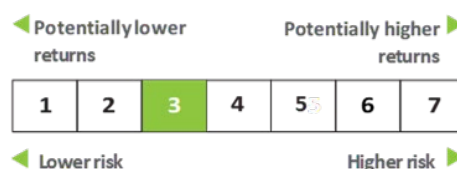
Description of this fund

The Lifetime Overseas Bond Fund seeks to track (before annual fund charge and tax) the Bloomberg MSCI Global Aggregate SRI Select ex-Fossil Fuels Index, 100% hedged in NZD. The Fund provides exposure to international fixed interest investments and is expected to experience low to moderate volatility.

What are the risks of investing?

Risk indicator for the Lifetime Overseas Bond Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

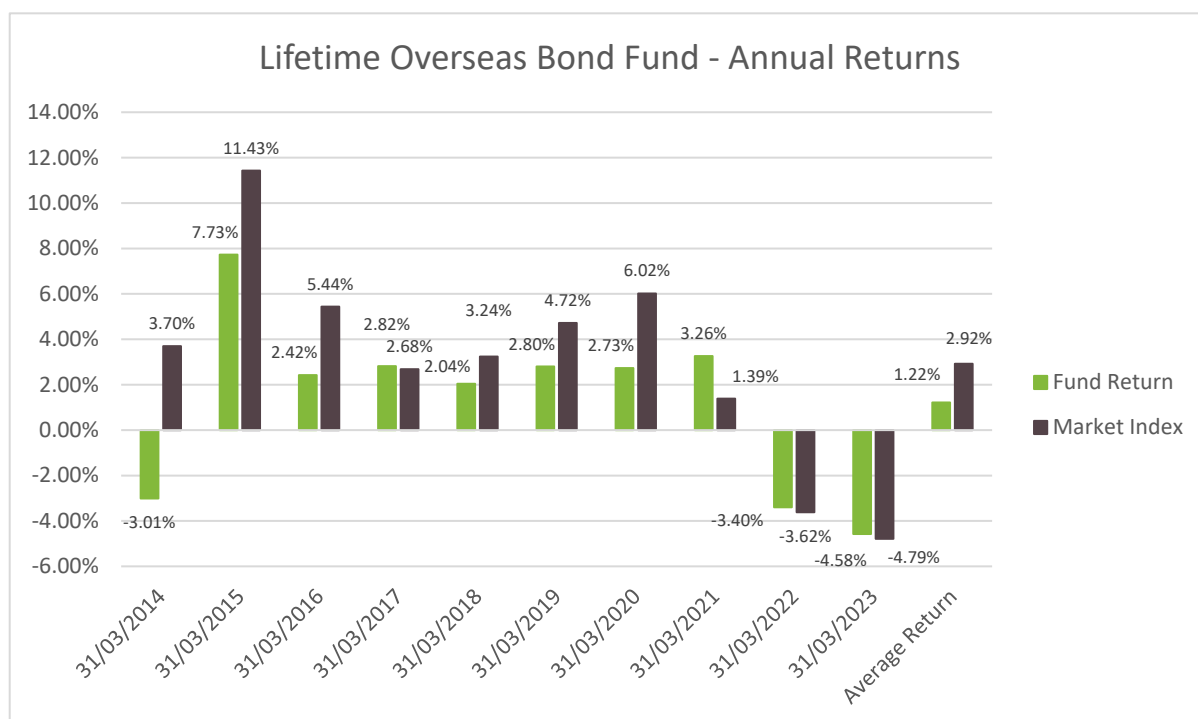

Annual membership fee calculation involves calculating the total of member fees payable across all those participating employers where the member pays for the fees and dividing by the total number of members from all participating employer and multiplying by 12 to convert to an annual average. Annual membership fees were charged during the period however they are no longer charged.

Small differences in fees and charges can have a big impact on your investment over the long term.

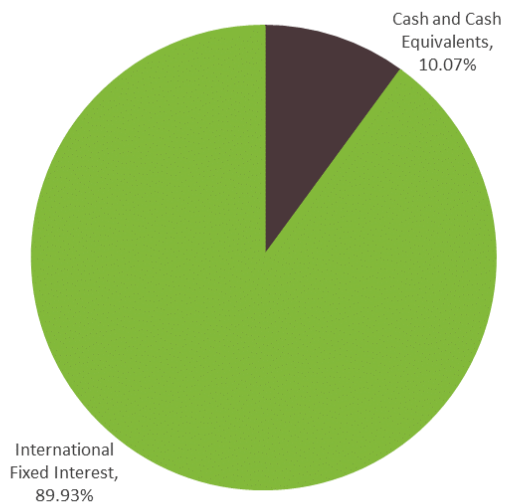
Example of how this applies to an investor

Ben had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben incurred a loss after fund charges and tax were deducted of \$457.59 (that is -4.58% of his initial \$10,000). Ben also paid \$22.35 in other charges. This gives Ben a total loss after tax of \$479.94 for the year.

What does the fund invest in?

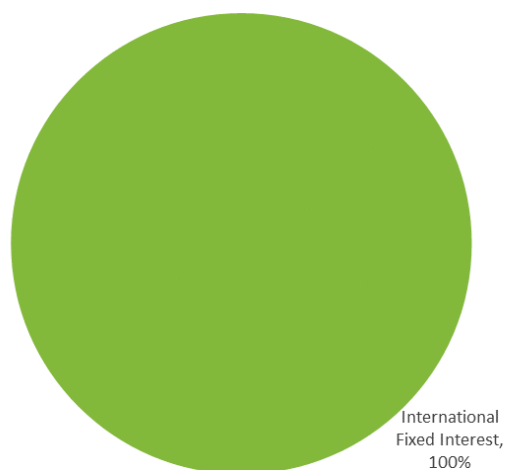
Actual investment mix
